EXECUTIVE BOARD MEETING MINUTES

CALL TO ORDER:

President Darrell Lowe called the meeting to order at 4:56 PM.

Approval of Minutes for 9/18/2024: **Motion by Sheriff Raymond. Second by Chief Batiste. Motion passed unanimously.**

FINANCE COMMITTEE REPORT:

Financial Statements - The statements are presented through August 2024. Figures under the 2023 columns represent the full year. No concerns to note in the statements. Expenses and revenues are as expected. Items worth noting:

- Page 2, Revenues (Contracts) Beginning July 1, Contract admin fees received from Jail Data API contract increased. (Monitoring) Contracted DOC clients have steadily been increasing throughout the year.
- Page 3, Expenses (Supplies) Replaced equipment for conference and internal general use. (Repair and Maintenance) – Exterior painting and major elevator maintenance during 2024.

<u>Disbursements:</u> Check number 46886 through 47073 (09/13/24-11/11/24) for \$8,968,344.72 (full listing provided in board packet)

Need motion to APPROVE the financial statements and disbursements. Motion by Sheriff Myers. Second by Chief Padilla. Motion passed unanimously.

2025 WASPC General Fund Budget

The Finance and Personnel committee reviewed the proposed 2025 General Fund Budget in detail by program/cost center. New cost center added this year for Jail Support Services.

Changes from prior year budgets include:

- (Contracts) Increased revenue for jail data extract contract with Health Care Authority
- (Conference) Moderate growth to conference fee and sponsor/exhibitor revenues,
- (Miscellaneous expenses) increased credit card processing fees
- (Salary/benefit) Staff changes in cost centers; Correctional Svcs, Legislative, and Jail Svcs
- (Repair and maintenance) Planning for major maintenance as building is aging.

Need motion to APPROVE the proposed 2025 general fund budget. Motion by Chief Bennett. Second by Sheriff Morris. Motion passed unanimously.

WASPC Grant Requests -

Three grant requests have been received and are included in the packet. The finance committee make the following recommendations:

- 1. Approve East Wenatchee PD Power DMS Module \$550
- 2. Approve Mukilteo in car scanners \$1,000
- 3. Decline Walla Walla PD Public Safety Analytics \$31,500

Need motion to APPROVE grant recommendations. Motion by Sheriff Morris. Second by Chief Padilla. Motion passed unanimously.

The finance committee reviewed the current WASPC grant guidelines. The committee will bring edits to the Executive Board at the February meeting for review.

Jamie Weimer provided an update on Sex Offender Model Policy changes.
