

State Uniform Crime Reporting Program

Step 1:

Establish a LEEP Account

- To access the Use of Force (UoF) program, you need a Law Enforcement Enterprise Portal (LEEP) account.
- To apply for a LEEP account, go to www.cjis.gov and click on "Apply for an Account" to complete the online application.
- Once you apply for your LEEP account, you can contact the FBI at useofforce@fbi.gov to expedite the enrollment process.



Step 2:

Apply for Access to the UoF Program

- After you have a LEEP account, log in and click on the National Use of Force icon.
- There, apply for the access to the UoF Program.



Step 3:

Begin monthly UoF Data Collection

- If there are no UoF incidents to report, enter a "Zero Report" for the month.
- If there is an incident, it is recommended that you complete a preparation worksheet before starting data entry.



NATIONAL USE-OF-FORCE DATA COLLECTION

PREPARATION WORKSHEET

Law enforcement agencies entering data into the National Use-of-Force Data Collection system may wish to use this worksheet to organize the information needed to enter a use-of-force incident. Agencies can complete the worksheet and have it available when logging into the Law Enforcement Enterprise Portal (LEEP) and accessing the National Use-of-Force Data Collection system.

The National Use-of-Force Data Collection is a component of the Uniform Crime Reporting Program and is used by law enforcement agencies to report a law enforcement use of force that results in a fatality, serious bodily injury to a person, or the discharge of a firearm at or in the direction of a person.

The definition of serious bodily injury is based in part on 18 United States Code 2246 (4) and means "bodily injury that involves a substantial risk of death, unconsciousness, protracted and obvious disfigurement, or protracted loss or impairment of the function of a bodily member, organ, or mental faculty."

What data elements are collected?

Data Elements Related to the Incident:

- Date and Time of the Incident
- Agency ORI and Case Number
- Physical Address of the Incident
- Location Type of the Incident
- Reason for the Initial Contact
- If the reason is "Unlawful Activity", the Most Serious Reported Offenses
- NIBRS (or Local) Incident Number Related to the Reported Offenses
- Did the Officer Approach the Subject?
- Was the Incident an Ambush?
- Was a Supervisory or Senior Officer Consulted?
- Total Number of Officers Who Applied Actual Force
- Number of Officers from Reporting Agency Who Applied Actual Force
- Total Number of Subjects Who Died, Received Serious Bodily Injury, or Had Firearm Discharged in Their Direction
- Case Numbers of Multiple Involved Agencies (if applicable)

Data Elements Related to the Subject:

- Age of the Subject
- Sex of the Subject
- Race and Ethnicity of the Subject
- Height of the Subject (actual or estimated range)
- Weight of the Subject (actual or estimated range)
- Apparent or Known Impairment in the Mental or Physical Condition of the Subject
- Did the Subject Direct a Threat at the Officer or Another Party?
- Resistance or Weapon Involved
- Was the Subject Armed or Believed to be Armed?
- Type(s) of Force Used Connected to Serious Bodily Injury or Death
- Subject's Injuries

Data Elements Related to the Officer:

- Age of the Officer
- Sex of the Officer
- Race and Ethnicity of the Officer
- Height of the Officer
- Weight of the Officer
- Officer's Years of Service
- Was the Officer Employed Full-Time?
- Was the Officer On Duty at the Time of the Incident?
- Was the Officer Readily Identifiable at the Time of the Incident?
- Did the Officer Discharge a Firearm?
- Was the Officer Injured?
- Officer's Injuries
- If injured, the NIBRS (or Local) Incident Number of the Report Detailing the Law Enforcement Officer Killed or Assaulted (LEOKA) Incident

- When ~ The FBI plans to publish the first Use of Force data in Summer 2020.
- Where ~ The data will be on the FBI's Crime Data Explorer (CDE) website.
 - https://crime-data-explorer.fr.cloud.gov/
- What ~ The data that will be published include:
 - ❖ Details on the number of agencies participating in the collection
 - The number of law enforcement officers represented geographically
 - ❖ A downloadable list of agencies enrolled or participating
 - * Response percentages including:
 - The number of agencies that submitted a zero report.
 - The number of agencies that submitted an incident report.
 - The number of agencies that did not submit anything for a given month.
