The following information has been put together In order to improve the effectiveness of the Sex/Kidnapping Offender Registry (SOR) / Offender WATCH interface and reduce the number of interface email messages you receive.

Offender Watch Interface Tips

- There should only be one record in Offender Watch per person. Don't have two records for the same person in Offender Watch.
- Use the suffix field appropriately. Don't put the suffix in the name fields.
- The name in Offender Watch should match the fingerprint registration sent to WSP. If the name in Offender Watch is Smith, Bob D. the name on the livescan fingerprint registration should be Smith, Bob D. and not Smith, Robert David. If the name is different and there is not an alias name in WASIS to match it you will receive a Not Found email message notification.
- When you receive a "Not Found" email message, use WATCHCJ to determine if there is a fingerprint registration on file in WASIS for your county. If not, submit a fingerprint registration if appropriate. If there is a fingerprint registration on file for your county, verify the name and date of birth in Offender Watch matches the information on the fingerprint registration in WASIS using WATCHCJ. If the name on the fingerprint registration doesn't match, submit a correction notice to correct the name on the fingerprint registration (name can't exceed 30 characters) or change the name in Offender Watch, whichever is appropriate.
- If a person has two first names or a hyphenated first name in Offender Watch you will
 receive an interface email message from WSP. NCIC doesn't allow for two first names or
 hyphenated first names. The name on the Offender Details page should match the name
 submitted on the fingerprint registration card sent to the WSP. Other names can be
 added to the Alias tab.
- Entering two different addresses of the same address type (mailing, residential, etc.) with the same start and end dates will cause an interface email message letting you know it can't be processed through the interface. You may also make adjustments to the dates in Offender Watch, if appropriate, to allow the information to transmit to WSP via the interface.
- Only the agency who submitted the fingerprint registration may change or update SOR information in WASIS. If the editing agency in Offender Watch has not sent a fingerprint registration card you will receive an email message letting you know it did not update WASIS.
- If you add/update/edit a record for an individual before the registration is processed at WSP you will receive an email message that the record is not found. Please make sure to send the registration promptly. There is a two day delay from the time you enter information into Offender Watch before it updates WASIS. Our goal is to process the SOR fingerprint registration the same day we receive it.
- If you have a record for someone in Offender Watch who is not registered in WASIS and never will be, such as a person who is civilly committed or someone who was deported without registering, you will receive a "Not Found" error message from WSP. Since the person is not and will not be registered, please ignore this message. There is no action for you to take.
- If you receive an interface email message and the issue can't be resolved you will need to send the SOR information to the WSP on the WSP forms via email/fax/mail.

The name field (ANA) is highlighted in blue and shows the name is over 30 characters long. WASIS and livescan devices can't accept names over 30 characters per NCIC requirements. To resolve this add the name submitted on the last fingerprint registration card sent to the WSP to the Offender Details tab in Offender Watch and add the name which is over 30 characters to the Alias tab in Offender Watch.
