WASPC STATEMENT ON POLICE REFORM LAWS

Law enforcement wants to help people in crisis. We welcome additional resources and support from our community partners. The model policies, due from the Attorney General in July 2022, should have preceded the implementation of these laws, not the other way around.

Law enforcement departmental practices and policies are established with guidance from legal advisors, interpreting the laws enacted by the legislature. Our discussions with legislators as well as statements made by members of the legislature have demonstrated that they acknowledge revisions to the new reform laws are necessary. We adamantly agree that fixes are necessary.

Additionally, we submitted a <u>list of questions</u> to Rep. Jesse Johnson (D-Federal Way) for clarification from an Attorney General's Opinion. We believe the AG opinion can provide important clarity, until needed legislative fixes for critical issues related to detention and use of force can be reached. We were advised the questions will be submitted to the Attorney General but have not received confirmation that they have, in fact, been officially sent or received.

In the 2021 Legislative session, WASPC supported clarifying amendments which were offered to help avoid the confusion of implementation of the laws related to police tactics and use of force we are seeing now. They were explicitly rejected by the legislature.
